Holland Student Council Citizenship Contract

Participation in Holland Student Council (STUCO) is a privilege and not a right.

Creditable citizenship is one of the criteria for participation as a member of the Holland Student Council. Creditable citizenship includes such things as regular and punctual attendance and a quality of conduct which promotes the best interests of Holland Elementary School. Therefore, students shall exhibit standards of behavior which will bring credit to the student, STUCO, Holland Elementary and the community.

It is imperative that student behavior be in compliance with School Board policy, Student/Parent Handbook Discipline Code and Regulations and with public laws. Repeated referrals of a student to the principal, (or any other person having general responsibility for discipline in the school) for misbehavior may be sufficient reason to declare a student ineligible. Should a single serious breach of good conduct, either in or out of school come to the attention of the principal, counselor, student's teacher or any other staff member the STUCO member may be removed from Holland Student Council. While it is not possible to cite every example of behavior that violates policies, regulations, or public laws or constitutes a breach of good conduct, activities such as bullying, cyber bullying (both in and out of school) and assaultive behavior are examples of specific behavior that will lead to dismissal from STUCO.

By signing this document both the student and parent/guardian agree that as a member of Holland Student Council the student will hold themselves to a high standard of conduct both inside and outside of school. Both the student and parent/guardian also agree to accept any consequences related to the violation of the Holland Student Council Code of Conduct.

General Expected Behavior and Responsibilities of STUCO members

Staff – Students have the responsibility of showing respect for the knowledge and the authority of school staff. Students must obey reasonable directions; use only acceptable and courteous language; and avoid actions that show contempt for school staff.

Themselves – Students have the responsibility to reasonably avoid any behavior that is detrimental to achieving their own or other students' educational goals. Students must cooperate in taking reasonable care of books, other instructional materials, technology, and encourage a climate where learning is cherished.

Others – Students have the responsibility of showing respect for the rights and human dignity of fellow students. For example, students must not engage in name-calling, fighting, harassment, bullying, belittling or engaging in deliberate attempts to embarrass or harm another student.

Responsibilities

STUCO members will be responsible for (1) exhibiting PRIDE behavior at all times – not just while representing STUCO, (2) assisting with the collection of recycling, (3) delivering STUCO related announcements to their class, (4) creating signs and banners for STUCO activities, (5) coming up with ideas for STUCO fundraisers & activities, (6) collecting money from STUCO fundraisers (under the supervision of an adult), (7) attending and helping out with STUCO sponsored activities (as often as possible).
